Note: As per the DOE, Delhi circular no.F.DE.15(172)/PSB/2016/9483-9492 dated 21.11.22, the age relaxation for admission of upto 30 days may be granted at the level of head of school in the minimum & upper age limit. The parents may approach the Head of School/ Principal for seeking age relaxation through a manual application.
